He attended Sunshine Business Academy's 12-week course where he learned entrepreneurial training, marketing strategies, financial guidance to boost, expand, and how to restart his business. Derrick has since graduated from Sunshine Enterprise Business Academy, created his official flyer, and purchased new cleaning equipment. Mr. Hayes recently received his very first contract post graduation. Husha Steam Carpet Clean is now the carpet cleaning service provider for a local daycare center.



HOUSING SPOTLIGHT



The Art of Lyman Terrace

The Community Builders led two phases of redevelopment of Lyman Terrace between 2016-2021. Serving as home to 164 families, the renovation of Lyman Terrace was completed in partnership with Holyoke Housing Authority. In the early 2010's, Lyman Terrace had become functionally obsolete and needed a revitalization to effectively support its residents and the economic redevelopment of downtown. Recognized in excellence in the U.S. Department of Urban Housing and Development Preservation category, Lyman Terrace was the recipient of two national awards: a 2021 Charles L. Edson Tax Credit Excellence Award and a 2021 Affordable Housing Finance Readers' Choice Award.

The surrounding grounds of Lyman Terrace is Holyoke's Pulaski Park. Pulaski Park is home to a new vibrant mural painted by master artist Tyrone Bowie, Jr. The mural features community members utilizing the park's many amenities.









NEIGHBORHOOD IMPACT



Neighborhood Investments

In 2021, TCB was awarded \$50MM in New Market Tax Credits (NMTC) that will bring positive benefits to highly distressed communities. TCB implements the NMTC program through a comprehensive community revitalization strategy focusing on areas where we have developed housing. TCB invests in assets to increase access to health care, healthy foods, quality education, employment opportunities, transportation and other services to neighborhoods.

Horizons for Homeless Children

Completed in 2021, the Horizons/Watermark Center will create a centralized location for social services and initiatives serving low-income children, youth, and families. Financed in part by our New Market Tax Credits, the facility will house youth and family-oriented non-profit services with 129,000 square feet of rentable space in the Roxbury neighborhood of Boston.

Neighborhood Transformation

TCB is proud to serve as the Choice Neighborhood Housing and People lead in Detroit and Cleveland! TCB, in partnership with the Cuyahoga Metropolitan Housing Authority, will transform Cleveland's Buckeye-Woodhill neighborhood with the redevelopment of the 30.5-acre Woodhill Homes.

The housing strategy is to build attractive, well-designed, mixed-income housing; strategically introducing transit-oriented development housing; bridging the short distances to strong housing and employment markets in adjoining neighborhoods. This place-based model uses highly visible, market-oriented design and amenities to amplify the new investment in the community and improve the well-being of Woodhill Homes residents by building 638 apartment homes in six phases.










88% of TCB residents in the Midwest have access to the internet




90% of TCB residents in the Mid-Atlantic prioritized their health by having a check-up last year


